

UNIT HISTORY

For the period from 1 February, 1945, thru 28 February, 1945, the Battalion suffered two fatal losses, one from battle wounds and one from NLD causes. **Eine**men were casualties, either LIA or LWA.

The Battalion did not take any prisoners of war.

There were no major transfers in Battalion Personnel. The battalion operated with under strength in both officer and EM personnel.

There were several promotions of noncommissioned officers within the Gun Companies. No change of officer personnel status.

The battalion participated during the first of the period, in the final action clearing the COLMAR POCKET of the enemy. During this action, commendation was earned from the French Corps Commander, with which our unit under the XXI Corps was operating. At completion of the objective, the 12th Armored Division, then our unit's immediate higher headquarters, was transferred to vicinity FALQUEMONT, France, reverting to XV Corp Area. Subsequently, the Battalion proceeded to the vicinity of BACCARAT and continued as a Tank Destroyer Battalion, under 68th AAA Group, for operation and reverting to Seventh Army for administration, severing its service under 12th Armored Division. The Battalion was then occupied with guarding designated projects in Communications Zone Area, for the balance of the period.





UNIT JOURNAL

- I February, 1945: Message received from 12th Armored Division, alerting battalion for movement to MOLSHEIM, France.
- 2 February, 1945: 1st platoon, Company "A" attached (Field Order 8, 12th Armd Division) to CCA and 2nd plat attached to CCB; 1st platoon, Company "B", attached to CCR (by same authority); remainder of Battalion alerted for movement.
- 3 February, 1945: In Officer brought order for Battalion to move vicinity St. HIPPOLYTE, France. Battalion crossed IP, STUTZHEIM, France, at 1600 hours, CP Group arriving at ORSCHWILLER, France, at 2015 hours.
- 4 February, 1945: G-3 Periodic Report #62 received showing 2nd plateon, Company "A", attached to TF BOONE, CCB; CCB reported closed in vicinity DAMBACH; CCR, including 1st plateon, Company "B", reported vicinity HOUSSEN, France; CCA, with 1st plateon, Company "A", reported vicinity BARR, France. In Officer arrived with orders attaching 12th Armored Division, including 827th TD Bn., to XXI Corps. At 1330 Bn. CP closed ORCHWILLER, beginning movement to BERGHEIM, France. Bn closed in BERGHEIM at 1510.
- 6 February, 1945: At 1015 Bn departed BERGHEIM, arriving PFAFFENHEIM, France, at 1230.
- 10 February, 1945: Bn departed PFAFFENHEIM, closing in BIONVILLE, France, at 0910 hours, 11 February, 1945. Per VOCG, 12th AD, one platoon Company "A" attached to CCR, reporting to CO thereof as soon as possible vicinity WOLFS KIRCHEN.
- 12 February, 1945: At 1730 In Officer arrived with verbal orders from CG, 12th AD, alerting Bn for immediate movement to BACCARA T, France; advance detachment ordered to report to 68th AAA Gp. At 2215 In Officer returned with orders from CG, XXI Corps, ordering Bn to move morning of 13 February, 1945. VOCG also relieved Bn from attachment, 12th AD (upon arrival vicinity BACCARAT), and attached to 68th AAA Gp for operations.
- 13 February, 1945: At 0530 Bn departed BIONVILLE, closing in VERDENAL, France, at 1915.
- 17 February, 1945: Letter of Commendation received from Major General F. W. MILBURN, CG, XXI Corps (for participation in operations, Colmar area); Bn attached to XV Corps for operation (see attached extract), remaining with 7A for supplies and administration. Written orders received confirming verbal orders for Bn movement to BACCARAT, and attachment to 68th AAA Gp

Remainder of month spent as prescribed by 68th AAA Gp, guard duty.




