SUBJECT: Recommendation for Award.

TO : Commanding General, General Headquarters, AFPAC, AFO 500.

- l. Under the provisions of AR 600-45, as amended, it is recommended that Major John M. Suardi, 0365754, Field Artillery, be awarded the Bronze Star Medal for meritorious services in connection with military operations against the enemy in the Philippine Islands during the period 7 August 1945 to 18 October 1945.
- 2. Major Suardi is my Executive Officer. During the period 7 August 1945 to 18 October 1945, Headquarters 13th Tank Destroyer Group operated the island base of Mindore, P.I. succeeding 8th Army Area Command Troops at APO 321. Major Suardi, Executive of the 13th Tank Destroyer Group, assumed the duties of an Adjutant General during the above period. Although the Adjutant Generals Section of the 8th Army Area Command, including an Adjutant General and a personnel officer, departed within a few days after arrival of the 13th Tank Destroyer Group, Major Suardi with a limited number of enlisted personnel, diligently and successfully administered more than 5000 troops, with outstanding devotion to duty, superior ability, initiative and fortitude. During this period it was necessary for him to work from 10 to 14 hours a day. seven days a week and on numerous occasions 24 hours a day to complete his mission, which he did as a matter of course. His outstanding devotion to duty greatly inspired all personnel working under him. He often refused to take a short recreational trip and denied himself many privileges to devote his entire efforts to his work.
- a. Major Suardi had many difficulties to overcome. He only had about 3 days to work with the old Adjutant General and had to familiarize himself with the procedure for handling a large number of troops. At the time that he assumed the duties of an Adjutant General there were 30 different units under this command. His only experience in the past was as an Adjutant of a Tank Destroyer Group. He handled all assignments which were new to him, with only 3 days to familiarize himself with the nature of the work, he assumed the duties of an Adjutant General which at the

time included administration pertaining to shipping, air fields, quartermaster, ordnance and engineer property, railroads, signal corps, white and colored port units, sanitary and malaria units, postal unit, finance, special service, graves registration, and Philippine Army. He overcome all difficulties which arose in administering these different type units and successfully accomplished his mission thru his superior ability, initiative, and fortitude. Major Suardi also handled all readjustment for all units under this command up to 18 October 1945 and on one occasion handled readjustment for the 96th Division. This Headquarters relinquished command of this Base to the 96th Division on 18 October 1945.

- b. In addition to his duties as Adjutant General it was necessary to assign Major Suardi additional duties as Judge Advocate, due to the limited number of officers in this headquarters. He also diligently and faithfully performed these additional duties though this meant a considerable number of hours would be spent at night to perform his duties as Adjutant General.
- c. Due to his untiring efforts and conscientious devotion to duty Major Suardi contributed greatly to the 13th Tank Destroyer Groups' success as the Base Command during the above mentioned periods.
 - 3. I have personal knowledge of the above incidents.
- 4. Previous decorations and awards, and authority for each: None.
- 5. a. Rank and organization at time of act: Major, Field Artillery (TD), 13th Tank Destroyer Group.
- b. Rank and organization at present time: Major, Field Artillery (TD), 13th Tank Destroyer Group.
- 6. Name, relationship, and address of nearest relative: Mrs Ruth E. Suardi, (Wife), 910 Miller Street, Clinton, Indiana.
- 7. The entire service of the above named officer has been since his entry on active duty as a Reserve Officer on 5 March 1940, to date, honorable, and his record shows a manner of performance as "superior" from 31 December 1943 to 17 October 1945, as rated by 4 different commanders, one of which was by a General Officer.
