- 29 March 44 Battalion, consisting of two serials, departed by rail for Camp Kilmer, New Jersey.
- 31 March 44 Battalion arrived Camp Kilmer, New Jersey, at 0230.
- 1 April 44 to 3 April BB Battalion was processed for overseas shipment.
- 5 May 44 Battalion moved by rail from Camp Kilmer, New Jersey, to Fort Dix, New Jersey. Battalion was assigned to XVIII Corps for training and administration.
- 13-14-15th June 44 All officers and platoon sergeants of gun companies fired indirect firing problems.
- 17 June 44 A Battalion Parade and Review was held during which the Battalion Standard was presented to Lt. Col. KOPCSAK by his daughter, CaroI. Colonel IARDER, Commanding Officer of the 8th Tank Destroyer Group, was present as reviewing officer.
- 26 June 44 Battalion moved by rail from Fort Dix, New Jersey to Camp Kilmer, New Jersey.
- 18 July 44 Battalion left New York, New York aboard the SS Bergensfjord for overseas duty.
- 29 July 44 Pattalion disembarked at Glasgow, Scotland, and proceeded by rail to Moreton-in-Marsh, England.
- 30 July 44 Pattalion arrived Moreton-in-Marsh and was assigned to Third U.S. Army and subsequently attached to TX Corps.
- 20 August 44 Battalion moved from Moreton-in-Marsh, England to Marshalling Area, vicinity of Dorchester, England.
- 21 August 114 Battalion moved by motor convoy from Marshalling Area, Dorchester, England to Portland, England and boarded LST for movement to France.
- 22,23,24 Aug 44 Unit aboard IST.
- 25 August 44 Unit disembarked at Omaha Beach, France and moved into bivousc area in vicinity of Formigny, France.
- 26 August 44 Battalion moved by motor convoy from Formigny, France to bivouac area vicinity of St. Hellaire, France.
- 27 August 44 Battalion moved by motor convoy from St. Hellaire, France to vicinity of Courtelain, France.

## 25 August-Lite Landed . Onaha Beach.

- 29 August 44 Battalion moved by motor convoy from Courtelain, France to vicinity of Rigny-Le-Ferrow, France. Unit attached to XII Corps and further attached to 9th T.D. Group.
- 30 August 44 Battalion, held in Corps Reserve, participated in attact on enemy in vicinity of Troyes, Brienne and Dolencourt. Unit was not committed to action. A Platoon of Company C, commanded by 1st Lt. Robert E. Graham, was sent to XII Corps to provide security for Corps Headquarters. Recl Co made reconnaissance of assembly area in vicinity of Blacy.
- 31 August 44 Unit moved by motor convoy to vicinity of Blacy, France. Rcn. Co. assigned mission of reconnoitering area bounded by Harouville, Chantourupt, Montier-en-Der. Gun companies assigned mission of reconnoitering areas of approach to Vitry from St. Dizier (Plan A) Wassey (Plan B) and Montier-en-Der (Plan C) and also selecting gun positions.
- l Sept 44 One platoon Ren. Co. and one platoons Co. A sent out to guard bridge over Marne River at Vitry Le Francois. Platoons returned at approximately 1400 hours. At about 1500 hours B and Ren. Companies began attact to eliminate an estimated 70 Germans in a forest in the Camp De Tir De Mailly Area. Two companies were engaged in attact returned to bivouac area at 2030. No casulties were sustained. No enemy were known to have been killed and none were captured.
- 2 Sept 44 Battalion moved from vicinity of Blacy to bivouac area in vicinity of Eitry Cn Perthois. Two sections of Reconnaissance Company are patrolling the Champ De Tir De Mailly area for possible Germans reported in forest.
- 3 Sept 44 Battalion/hof/s/fiph remained in bivouac vicinity of Vitry En Perthois. In Red Cross visited unit and werved doughnuts and coffee. No unusual incidents.
- . 4 Sept 44 Battalion remained in bivouac vicinity of vitry En Perthois.
- 5 Sept 44 Battalion remained in bivouac vicinity of Vitry En Pertois. Total of fourteen prisoners captured and evacuated, 1 by Company and thirteen by Rcn. Company.
- 6 Sept 44 Battalion moved to new bivouac area vicinity of Cey.
- 7 Sept 44 Rcn. Company and A Company attached to 2nd Cavalry Group and left present bivouac area about 1330. Company B attached to 4th Armored Division but remained in present bivouac area. Remainder of battalion remained in bivouac vacinity of Oey.
- 8 Sept 44 Company B left battalion bivouac area vicinity of Cey at 0800 to join 4th Armored Division. One Platoon of Rcn. Co. attached to Company B. Battalion, less Company B, one platoon of Rcn. Co. and one platoon of Company C, attached to 2nd Cavalrt Group, and moved from vicinity of Cey to vicinity of Goviller.

9 Sept 44 Company C less one platoon, assigned mission of covering and holder bridge across Madon River in vicinity of Haroue. Company A assigned mission of covering and holding bridge across Madon River at Xirocourt. Reconnaissance Company, less one platoon, made reconnaissance to the south and around Socourt and Braliville. Company C contacted enemy vicinity of Roville. Losses; 2 enlisted men killed; one enlisted man seriously wounded, one t ton truck and M-18. Damage inflicted on enemy: One battery of field artillery knocked out. Pvt. Winnery of Rcn. Company credited with destroying a machine gun nest with an M-1 rifle. Losses of Rcn. Company: One motercucle. Rcn. Co. and Company C both subjected to frequent artillery shellings and forced to withdraw.

10 Sept 44 Companies continued on missions assigned on 9th Sept. pending arrival of supporting units. Command Post at 1800 hours from vicinity of Goviller. Company B, plus second platoon of Rcn. Company relieved from attachment to 4th Armored Division and returned to bivouac area at about 2100. Platoon of company C, used as security for XII Corps Head-quarters since 30 August relieved by 691st TD Rn and returned to bivouac area at about 1500. Company C and Reconnaissance Company subjected to periodic artillery and mortar fire. One prison er captured and evacuated by Rcn Co.

Moselle River and thes battalion assigned mission of protecting south flank of XII Corps generally along the east west line of Mt. Sion, Xirocourt and Gripport as other units attempted to cross the Mosselle River. The battalion was relived from attachment to 2nd Cavalry Group and reattached to 9th TD Group effective at 0500. However Mitiunit was to remain under control of Corps and 2nd Cavalry Group until crossing of moselle River is completed. A Company plus 1st platoon Rcn. Company attached was assigned the east west sector between Mt. Sion and Xirocourt to include the modon River. Company C plus 3rd platoon Rcn Company was as signed the east west sector between Xirocourt and Gripport. Company B plus 2nd platoon Rcn Company held in reserve. Company A captured and evacuated and evacuated one prisoner. Dattalion Commander received verbal recommendation from Colonel Read, Co, 2nd Calvalry Group, for work of this battalion during the period 8 Sept. to 10th Sept. 44 inclusive.

12 Sept 44 Battalion, less rear echelon and Company C, moved from Vicinity of Chaouilley across the Moxelle River to Birecourt. Battalion is now with leading elements of the bridgehead around Bayon.

13 Sept 44 Company A plus one platoon Rcn Co. assigned mission of covering routes of approach and selecting gun positions in the sector of Froville, Bremoncourt, Domptail and St. Ward. Company B, plus one platoon Rcn Co. assigned same mission in the Froville, Billacourt and southwest to the Moselle River. French reported our Rcn. outposts as being first American troops in Einvalix. Battalion CP moved at 2000 hours from vicinity of Virecourt to vicinity Mehoncourt. Missions were assigned as follows: Co A plus one platoon of Rcn Co. to proceed to Chamois and provide guard for supply traines moving nowth and northeast.

- 13 Sept 44 Count'd One platoon Company B to guard bridge at Lamath. Remainder of B Company with one platoon Rcn attached to proceed to Mont and provide guard for supply trains moving northeast. C Company to proceed to Bayon and guard bridge across Moselle and cover roads leading into Bayon.
- 14 Sept 44 Battalion CP remained in vicinity of Mehoncourt. Company A continued on mission assigned on 13 Sept. Company B retarmed to vacinity of Bayon to guard bridgehead established there. Company C moved from vicinity of Bayon to vicinity of Mont to protect the supply trains of Withers Column. Rear echaon moved from vicinity of Goviller to vicinity of Bayon.
- 15 Sept 44 ALL COMPANIES ON MISSIONS. Company C lost one ‡ ton truck and 3 enlisted men slightly wounded in action in vicinity of Luneville. Vehicle believed to have been hit by German 88mm gun. Gun position later located, reported to artillery command, and later believed to have been silenced by artillery fire.
- 16 Sept 44 All companies continued on missions, moving to the north and northwest. C Company assisted in knocking out enemy mortor position and capturing fourteen prisoners. Rcn CP moved from vicinity of Virecourt to vicinity of Mudiviller.
- 17 Sept 44 All companies continued on missions. 3rd platoon Ren. Company engaged with enemy, suffering one casualty, Ianni, slightly wounded. Two anti-tank guns knocked out by 3rd platoon Ren Company. Battalion CP moved from vicinity of Hudiviller to Couresseaux. Company A knocked out six tanks, six anti-tanks guns and killed 100 of the enemy.
- 18 Sept 44 All companies continued on missions. C company knocked out two anti-tank guns and three loaded gasoline trucks. B Company knocked out machine gun emplacement and killed eight enemy. Battalion CP moved from vicinity of Courbesseaux to vicinity of Sorenvillie.
- 19 Sept 44 Battalion, less one platoon B Company which was guarding bridge at Maixe, returned to an assimbly point in vicinity of Virecourt to neutralize a threatened tank attack, developing to the east and south of Luneville. Battalion attached to 2nd Cavalty Group.
- 24 Sept 44 Companies continued on missions. B COMPANY ENTERED Coincourt but later withdrew to high ground surrounding the town when enemy began shelling town about dusk. Reinforcements for Company B failed to arrive as soon as needed.
- 25 Sept 44 Battalion CP moved from vicinity Lezey to vicinity of Arracourt. C Company occupied positions vicinity of Suvelize. B Company remained in positions vicinity of Bures, and one platoon Reconnaissance Company remained attached to each company.

- 26 Sept 44 A, B, and C Companies continued on previously assigned missions. B Company forced to withdraw in face of heavy counter-attacks.
- 27 Sept 44 Battalion CP and mear echelon moved from vicinity ARRACOURT to vicinity of DROUVILLE. Gun companies continued on previously assigned missions. Seven counterattacks in CCB sector in which Company B worked were repelled. A Company captured 11 prisoners, lost one 11 ton truck. Reconnaisance platoon attached to A Company lost one ton truck.
- 28 Sept 44 Gun companies continued on missions. B Company knocked out one Mark IV tank, captured 8 prisoners, lost one M-18 and one mortar. C Company relieved and moved to vicinity of Serres for a rest period. A Company plus one platoon Recommaissance Company attached to 2nd Cavalry Group. Readquarters Company lost one motorcycle.
- 29 Sept 44 Battalion CP, rear echelon and C Company moved to vicinity of LANEUVELOTTE. B Company knocked out one tank. Company knocked out 8 tiger tanks, 3 armored cars and unknown mumber of personnel. Battalion, less Company A, which is attached to 2nd Cavalry Group, attached to 9th TD Group. 30 per sonnel killed by B Company.
- 30 Sept 44 B Company remained in positions around ARRACOURT, still in contact and engaged with enemy infantry and tanks. No change in A Company's position. No other changes.
- LOCK 44 Ron Company made reconnaissance of routes leading to tentative gun positions in a defensive sector prescribed by 9th TD Group generally in the sector MAIXE North to ARRACOURT, east to LEYRE. This is known as plan A. Overlays of plans submitted to 9th TD Group, 50lst Ord Bn made technical inspection of C Company's M-18's. Companies in resy area worked on motor maintenance. B Company returned to ASSembly Area vicinity of LANEU\* VELOTTE for a rest period. Ron had 2 M-8's damaged. "B" Co lost one 1 ton truck.
- 2 Oct 44 Rcn Company made reconmaissance of routes leading to, and splected tentative positions in a defensive sector prescribed by 9th TD Group generally in the sector DOMBASLE North to REMEREVILLE and northeast to CUSTINES. This is known as Plan B. Overlays of plans submitted to 9th TD Group. Companies in rest area continued work on maintenance. Personnel from C. Rcn and Hq Companies taken to NANCY for showers. General Ernst visited Battalion DP at about 1500 hours.
- 3 Oct 44 B Company abd C Company continued work on motor maintenance. A Company still in position.

4 Oct 44 Company B continued motor maintenence work, also had inappeation of small arms. Convoys from Rcn, Hqs and B Companies taken to NANCY for showers and movies. Company C, plus one platoon Rcn attached, moved from bivouac area vicinity LANEU-velotte to vicinity of LOISY in Corps reserve to support 80th Infantry Division. Moved out of bivouac area at 1545 hours. Lt. King, Rcn Company reported to 80th infantry Division as liaison officer. A Company remained attached to 2nd Cavalry Group.

5 Oct 44 C Company made reconnaissance of possible gun positions in 80th infantry Division Sector and submitted overlay to this headquarters which was forwarded to 9th TB Group. B Company continued work of motor maintenance. No others changes. All personnel were paid for the month of September.

6 Oct 44 One platoon Rcn Company ordered to make reconnaissance in vicinity of MONCEL SUR SEILLE at 0530. B Company alerted for possible movement to this area to meet a threatened tank attack. At 1000 hours B Company taken off the allert. Rcn platoon returned to the area at about 1030. Tank attack did not develop. Movie "This Is The Life", shown in CHAMPENOUX for B and Rcn Companies. B Company had one motorcycle damaged in an accident. No one injured.

7 Oct 44 No change in tactical disposition of gun companies. C Company is to support 80th Infantry Division sector until new MLR is established. One M-18 was drawn as replacement and issued to C Company. Red Cross visited Hq Company, B and Rcn Companies, serving doughnuts and coffee. Movie "This Is The Life" shown for Hq Company.

8 Oct 44 One section Rcn Comppany alerted and sent to area CHATEAU SALINS and MONCEL with mission of road screen. Left assembly area vicinity LANEUVELOTTE at \$6755. Company C supported 80th Infantry Division in attack. Mnocked out one ovservation post, one truck captured 16 prisoners. Authority has been received for this unit to reorganize under 1/0 and 1/E dated 15 March 44/ However, no action toward reorganization is to be taken until so directed by high headquarters.

9 oct 44 a Company relieved from attachment 2nd Cavalry Group and returned to assembly area vicinity LANEUVELOTTE. C Company supported 50th Infantry Division in attack, knocking out one machine gun and number of buildings destroyed at NOMENY.

10 Oct 44 Rcn Company made reconnaissance of Plans A-6, A-7 and B-6 and reports of Rcn submitted to BnS-3. A Company worked on motor maintenance and small arms. C Company continued mission  $\phi n$  of supporting 80th Infantry Division.

- Il cet 44 C Company continued on mission of supporting 80th Infantry Division. One platoon B Company attached to 4th Armored Division to work with 2nd Cavalry Group. Platoon reported to 2nd Cavalry Group at 1110 hours. B Company had one M618 damaged by land mine. One M-18 drawn and issued to B Company.
- 12 Oct 44 C Company and one plateon B Company continued on missions. No other changes. C Company knocked out one observation post. Physical inspection of all inlisted personnel made by Bn Surgeon. Movie shown for Battalion.
- 13 Oct 44 B Company knocked out one Mark IV Tank. No other changes.
- 14 Oct 44 One platoon Rcn Company, A Company, B Company less one platoon, moved into positions vicinity MAZERULLES and ERBEZ VILLER, respectively, at about 1800 hours, prepared to meet a possible tank attack from vicinity of CHATEAU-SALINS and CHANBREY. C Company moved from front lines to assembly position in vicinity of LANDREMONT.
- 15 Oct 44 A Company and B Company, less one platoon, recieved missions of supportions field artillery units in firing missions. Liaison made with field artillery as to administrative and supply details and also selected gun positions. No other changes.
- 16 Oct 44 A Company, working with 738th Field Artillery Bn, occupied foring positions vicinity of MAZERULLES. B Company, working with 273rd Field Artillery Bn, occupied positions vicinity ATHIENVILLE. Both companies registered on check points and were prepared to fire concentrations by 1700 hours. No other changes. Colonel Berry visited Battalion Command Post from 1500 to 1530 hours.
- 17 Oct 44 No changes.
- 18 Oct 44 B Company knocked out one observation post. No other changes. Eleven replacements and one casual recieved.
- 19 Oct 44 A and B Companies continued on missions, registering in on base points, firing harrassing and intordictory fire vicinity CHATEAU-ASLINS. No other changes.
- 20 Oct 44 A and B Companies continued on missions. Same type firing as previous day. No other changes. Major General EDDY visited Battalion CP at 1530 hours, making presentations as forlows: Silver Stars to Capt. Walter D. Hart, S/Sgt Otha H. Shannon, Sgt Philip Bonelli and Pvt Max Robotnick; the Bronze Star Medal to Sgt James Winney and the Soldier's Medal to Sgt James B. Mc-Carthy/
- 21 Oct 44 A and B Companies continued on missions, firing at same type targets. No other changes.

- 22 Oct 44 A and B Companies continued on missions. A Company knocked out one anti-tank gun, and battery (4) of enemy guns.
- 23 Oct 44 A and B Companies continued on missions. Message of commendation received from Corps and Group Commanders.
- 24 Oct 44 No changes.
- 25 Oct 44 No changes in tactical dispositions or missions. Tentative plans made to withdraw C Company on 26 Oct 44 to assembly area vicinity of LANEUVELOTTE.
- 26 Oct 44 C Company moved from vicinity of LANDREMONT to vicinity of LANEUVELOTTE. Battalion made plans to move to vicinity of ATH-IENVILLE.
- 27 Oct 44 Battalion, less Hqs Company, l platoon of B Company and two platoons Rcn Company moved to vicinity of ATHIENVILLE. Battalion, less one platoon 66 Company B which is attached to 2nd Cavalry Group, attached to 26th infantry Division. C Company, in support of Dicision Artillery surveyed in preparation to fire at 1400. Harrassing and interdictary firing missions assigned C Company. Effect unknown. A Company, in support of Division Artillery did no firing. One platoon Company B plus one section Rcn Company attached to 104 Infantry Regiment and 101 Infantry Regiment respectively.
- 28 Oct 44 C Company continued on missions of harrassing and interdictory firing. A Company surveyed in and fired first mission at 1830 hours. A Company destroyed one ammunition dump. C Company destroyed one OP and three trucks.
- 29 Oct 44 Commanies continued on missions. A Company knocked out one machine gun.
- 30 Oct 44 A Company relieved on field artillery mission at 1400 hours and will be held in reserve. No other changes. Major General PAUL, 26th Infantry Division Commander visited Battalion Command Post at 1500 hours.
- 31 Oct 44 C Company lost one 1 ton truck and one inlisted man slightly wounded by artillery fire. Company A and two platoons Ren Company alerted at \$650 hours. Taken off the alert at 0830. No other changes. Brigadier General Ernst, Colonel Berry and Lt Col Darling visited pattalion Command Post.
- 1 Nov 44 No Changes.
- 2 Nov 44 Co C relieved from indirect fire missions with 101 FA Battalion and is in support of 104 Infantry Regiment. One platoon of Co B supporting 104 Infantry Regiment relieved and reverted to company control. All troops paid today for month of October 1944.

- 3 Nov 44 Co A remained under battalion control. One platoon Co B attached to 101 inf Regt, remainer of Co attached to 2nd Cav Group. Co. C, less one section, attached to 104 Inf Regt. One section Co C attached to Hqs Co. 26th Infantry Division.
- 4 Nov 44 Plans made for future operations. Contact made with following attached units: 761 Tank Battalion, Co K, 101 Inf Regiment, and one plateon Co C, 101 Engineer Battalion. Reconnaissance Company, less one plateon attached to Co B, moved from wicinity of LANEUVELOTTE, FRANCE to vicinity of ATHIENVILLE, FRANCE. Z
- 5 New 44 No changes in disposition of companies. Continued in making plans for future operations.
- 6 Met 44 No changed in disposition of companies. Unit attached to 26th Infantry Division for administration. Plans made to move personnel section to division rear echelon.
- 8 Nov 44 Commanders rebriefed on future operations. Company C relieved from attachment to 6th Cavalry group and reverted to battalion control. One platoon of Co B and one platoon of Co A supportion 104 Infantry Regiment and 1700 hours.
- 9 Nov 44 Task Force A, commanded by Lt. Col. Kopcsak, and consistings of 602nd TD Bn., less Co B and one platonn of Co A, plus 761 Tank Battalion, less Co A, plus Co K lolst Infantry Regiment and one platon of Co C, lol Engineer Battalion, moved from vicinity of ATHIENVILLE, FRANCE at 0630 hours and advanced to just west of MORVILLE, FRANCE, encountering heavy resistance particularly artillery and mortor fire. Lt. Col. Kopcsak. wounded at about 1500 hours and Lt. Col. Hunt assumed command of Task Force. Major Conlis assumer command of 602nd TD Battalion. The Task Force witherew to the vicinity of VIC SUR SEILIE, FRANCE at 1700 hours. Ren Co captured 7 prisoners and lost one ‡ ton truck.
- 10 Nov 44 CCA, compased of 761 Tank Battalion (less) and Co A, 602nd TD Bn remained in division reserve. CCB, composed of Co C, 602nd TD Bn plus Co C 761st Tank Bn attached to 101 Infantry Regiment. A Company knocked out two machine guns and captured eight prisoners.
- 11 Nov 44 No Changes.
- 12 Nov 44 One platoon Co A attached to 328 Infant#y Regiment. Remainder of Co A Attached to CCB. Two platoons Co B remained attached to 2nd Cavalry Group. One platoon Co B remained attached to 104 Infantry Regiment. Two platoons Co C attached to CCA. One platoon Co C attached to 328 Infantry Regiment.
- 13 Nov 44 Co A attached to 101 FA Battalion for indirect fire. Registered in and prepared to fire at 1630 hours. Knocked out one observation post. Go B knocked out one Mark V and one Mark VI tank, one 88mm gun, one personnel carrier and killed twenty- five personnel. Co B lost one M-18.

- 14 Nov 44 Task Force A, 26th Infantry Division, dessolved Co B knocked out one armored car. Co C knocked out two pillboxes and killed twenty personnel.
- 15 Nov 44 Battalion CB, Rcn Co, less two platoonsk and Co C moved to vicinity of OBRECK, FRANCE. Co A, lass one platoon, remained in vicinity of VIC SUR SEILLE, FRANCE Attached to 101 FA Battalion.
- 16 Nov 44 No Changes.

- 23 Jan 45 On Division order, Co A was moved to Homroulle and Rcn to Savy, the two nearest towns to Bn CP. All Bn elements except Hq. and C are now in same general area. The 7th TD Group gave its pass quota to this unit. Division chief of Staff approved and 2 officers and 5 enlisted men were sent to Paris on 3 day pass.

- 29 Jan 45 345th Inf Regt with Co B in support made progress east of St Vith. Co A moved up near St Vith pre pared to operate call. At 2000 plans were made by Division to send a CombatTeam north into zone of 84th Division in order to outflank opposition in front of the 87th Division. Co A, without Rcn platoon, was wad made part of this Combat team and moved to assembly area, north of St Vith at midnight. Co B lost one jeep to a mine, no men were hurt.

- 3 Feb 45 Co B relieved by one company of 607th TD Bn and assembled vicinity St. Vith. Co A, Rear Echelon and Co B rear echelon moved to new assembly area vicinity of Huldange, Luxembourg.

- 25 Feb \$52 Bn was detached from 11th Armored Division and put under 7th TD Bn control. Co A was attached to 6th CAV Gp and moved to vicinity of Arzfeld, Germany.
- 26 Feb 45 3rd platoon Rcn Co relieved elements of 705 TD Bn Guarding two RR Bridges near Ettelbruck, No other changes in disposition.
- 27 Feb 45 Co B, with 2nd platoon Rcn Co, moved out at 0800 and replaced Co A and 1st Rcn Co platoon. Exchange completed at 1800. Co A moved to Huldange. Co A reported on action to the day: Knocked out 1 truck 1 machine gun, one mortar, 1 observation post; ca; tured 7 prisoners; killed 20 enemy; expended 40 rounds of HE, 10 rounds of APC.
- 28 Feb 45 Co B and C continued advance to cast under 6th Cav Gp. Bn was notified to expect remaining personnel to be assigned to guard vital bridges and tunnels in Corps Zone.

- l March 45 Co A furnished 90 men, Recon Co furnished 21 men from 1st platoon (in addition to 21 men from 3rd platoon who were already detailed) to guard vital railroad bridges and tunnels.
- 2 March 45 Co B knocked out one tank, one observation post and took four prisoners. Co C and Co B continued advance with the 6th Cavalry Group and reported 400 rounds HE in current drive. Hq Co sent 12 men out on bridge guard and Recon Cp sent 18 more. One officer was received and sent to Co C.
- 3 March 45 Captain Coulston and 4 enlisted men went on pass to Paris. Three men returned to duty and 27 new men were received. All new men were from Armored Force training Center, had 6 months in the army, and had no combat experience. The additions brought the Battalion to full T/O strenght except for one officer and one warrant officer.

Co B knocked out 3 OP's, 2 machine guns, 2 pillboxes, destroyed a road block, took 57 prisoners, and killed 22 enemy.

- 4 March 45 Co Band C reached Kyll River with Cavalry. Second Platoon Rcn Co reverted to control of Rcn Co and returned to Ourth, Belgium. All replacements received day before were assigned to Co A and Capt. Oliver began a course of instruction to acquaint them with TD equipment and tactics.
- 5 March 45 2nd Platoon Rcn Co replaced some off the Co A men off bridge guard in order to make available more instructors for the new men. Word was received that B and C Companies were moving with the 6th Cavalry Group to the Corps north flank. Billeting party went out to select new location for Bn CP.
- W March 45 B and C Companies took up positions with the Cavalry on the Corps north flank. Word was received that our men would be relieved from bridge guards the next day.
- 6 March 45 Bn CP moved to Winterspelt, Germany, VP 9180, setting up the CP on German soil for the first time. Capt. Oliver and 4 enlisted men left for 72 hours pass in Paris. Major Conlin left for 3 day leave in London. Report on Co C's operations for 3rd and 4th March; Knocked out 6 machine guns and one OP, killed 46 enemy, and captured 50 enemy.
- 8 March 45 All men were relieved from bridge guard. Hq, Rcn and A g prepared to move on Bn order to vicinity of Bleialf, Germany.
- 9 March 45 B and C Companies under control of the 6th Cavabry advanced toward the Rhine. The extent of their progress could not be determined. Hq, Rcn and Co A moved to vicinity of Bleialf, Germany.
- 10 March 45 Co B knocked out one truck , took 462 prisoners. All other elements remained in position in Corps Reserve.

- ll March 45 Bn received warning order to expect a long move. At 1915 word was received that the Bn complete was attached to XII Corps. Lt. Cage and Lt. Crouch left immediately to contact XII Corps at Birburg.
- 12 March 45 Bn (less B and C) left vicinity of bleialf at 0600 and arrived vicinity of Dudeldorf at 1000. Total distance traveled 45 miles. Bn CP and Hq located in Gindorf, Rcn at Picklisseim, Co A at Ordorf. B and C Companies left their areas vicinity Kilberg and chosed in Dudeldorf at 1400. Bn attached to 89th Infantry Division upon arrival. Co A is to be attached to 353 Inf Regiment, B Co to 354th Inf Regiment.
- 13 March 45 Co A moved with Regiment to Bad Bertrich; 1st and 2nd Rcn platoons went with Co A and Co B respectively; The rest of the Bn moved to Immerath. Companies in the live met little resistance. Lt. Whitman and 4 enlisted men went on pass to Paris.
- 14 March 45 No change in dispositions.
- 15 March 45 Bn less C attached to 353 Inf Regiment; Co C attached to 354th Inf Regiment. Plans made for crassing Moselle River, Main effort to be made by 353rd Inf Regt. Hq Co moved to Driesch.
- 16 March 45 Bn CP moved to Burren. Also Rcn Cp, with Pion. Platoon, moved to Bueren. "A" Co with 1st plat Rcn Co crossed Moselle to Merl. Co B with 2nd Plat Rcn, crossed Moselle to Neef, and captured 6 PW's. Co C with 3rd Plat Rcn Co was attached to 355 Inf Regt, prepared to move with 1lth Armored Division through zone of 89th Inf Division.
- 17 March 45 Bn CP moved to Mera. Co A moved out to the east with the 353rd, to Moritzheim. Bn less Co A and C was attached to 354th Inf Regt. Co C with 355th Inf Regt followed 11th Armored Division in their attack to the east.
- 18 March 45 Bn CP moved to Raversbueren (L6351), Co A to Panzweiler (L6958). B Co to Gosenroth (L7043), CoC to Kerchburg (L7649). Resistance was neglegible, the weather was clear, the roads were good, and progress was excellent.
- 19 March 45 Bn less Co C attached to Division again with mission of protecting Division and Corps right flank. Hq Co moved to Raversbueren. Rcn and Bn moved to Buchenburen (L6747), Co A to immenach (L6147), Co B stayed in Gosenroth, Co C/morth/the/the/the/the/bif/Bhefen/Aid / Innehach/ moved to Kirn (L8032). Total prisoners taken 42. Co A took the two towns of Bueren and Immenach. Pioneer platoon reduced two road blocks. At 2100 Bn received additional mission of protecting flankas after crossing Nahe River.

20 March 45 B Co with 2nd Rcn Platoons and Pioneer Platoon moved out at 0730 and by 1030 had crossed the river at / Fischbach. Co A with 1st and 3rd Rceon platoons moved out along a northern route parallel to B Co. Bn less C by nightfall was in vicinity of Mittelreidenbach (WL 7925). By 0800 Co C had crossed the river at Kirn and by nightfall had reached Lautershein (WM 2610). This particular day proved to be the most successful in the history/pf// of the battalion. No complete reports on Co C could be obtained, but their progress carried them almost to the Khine River. Co A took over 200 prisoners, B Co took over 400 prisoners. The two companies cleared a half-dozen towns on the Division flank and made contact with the 16th Cavalry Squadron from the XX Corps, near Fischbach on the Nahe River. The Battalion suffered no casualties. B Co knocked out or overran 1 tank, 4 artillery pieces, 4 m mortars, and 13 anti-tank guns.

21 March 45 Co C mived on to Horchhein (WM 4212) was detached from 355th Inf Regt, and assembled in place. A and B took six more small towns in the area, but did not change their CP's. 133 more prisoners were taken by A, B, and Rcn, including ? officers. Hq Co moved from Raversburen to Obereidenbach (WL 8023) B captured 3 Anti tank guns and one mortar. C Co took 389 PW's.

- 22 March 45 Companies performed maintenance and remained in place.
- 23 March 45 No Change.
- 24 March 45 Bn CP moved to Beltheim (L 8067) and A, B, and C and Rcn assembled in the same vicinity.
- 25 March 45 Co A attached to Task Force Ingell. B and C Companies attached to Task Force Johnson prepared to explicit bridgehead across Rhine to be made at 260200.
- 26 March 45 Division crossings were successful, but no bridge was put in. Both task forces went up thruggh the 87th inf Div Area and crossed the Rhine at poppard. They then cut south in rear of the 89th Division Bridgehead and eased the pressure sufficiently that a bridge could be started. Task Force Johnson then headed east and went approximately 10 kilometers to Struth. Task Force Ingell ran into some opposition and rugged terrain and remained in the vicinity of Kaub.
- 27 March 45 Task Force Johnson moved on to Kemel, another 10 kilometers east against only scattered resistance. Task Force Ingall was unable to advance beyond Presberg, some 8 kilometers east of the river. Capt. Hart was wounded and evacuated. Lt Barthold took over command of Co B. Co A killed 14 enemy enlisted men and 1 officer on a river boat and knocked out 4 flak guns.

- 28 March 45 Bn CP, Rcn CP and Hq Co crossed Rhine and moved to Dorscheid. B and C with Task Force Johnson advanced to Bad Schwalbach, some 25 kilometers east of the Rhine. A Co did not advance. Co C got I self propelled Mark IV tank. Co B got 5 flak guns, ll trucks, 4 trailers, and took 107 enlisted PW's and 8 officer PW's incluking 2 Colonels. At 2000 hrs the two task forces, having completed their missions were disbanded. A was attached to 355 inf Regt, B to 354th Inf Regt and C to 353rd Inf Regt for the next day's operations.
- 29 March 45 Companies worked with their respective regiments in cleaning up the remaining pockets in the zone. Co C got 6 flak guns. Small groups of prisoners continued to surrender without a fight.
- 30 March 45 Bn CP, Hq, and Rcn moved to Kemel (M2074). Capt Hart returned to duty. Mopping up operations continued satisfactorily.
- 31 March 45 Co B manned road blocks in 354 Inf Regt sector, but the area was quies. All companies performed maintenance.
- l April 45 Companies continued maintenance as Division remained in Corps Reserve. A film was obtained from Division Special Service Officer and was shown in Kemmel for HqRcn and C Companies.
- 2 April \$5 During the day the companies continued maintenance. At dark A Co with the 353rd Regt and C Co with the 355 INf Regt moved out to concentration area vicinity of Hersfeld (H3955), road distance about 130 miles.
- 3 April 45 B Co with the 354th Regt, moved up to concentration area. Division began relief of 90th and 65th Division elements. Bn CP, Rcn and Hq Co, also moved up to vicinity of Hersfeld.
- 4 April 45 C Co, with 355 Regt, moved to Gotha (J0965) and was placed under operational control of the 4th Armored Division. Co B moved to Archfeld (H6974), A Co moved to Unterellen (H7066) Bn CP moved to Wolfterode (H5971).
- 5 April 45 Hq Co and Rcn Co moved to Wolfterode. Capt Graham, Lt King and 10 enlisted men left on 72 hour pass to Paris. The Division encountered unexpected resistance in Eisenach and no appreciavle gains were made; B Co took 10 prisepers, Knocked/ont/ Rcn Co took 7 prisoners. A Co took 86 prisoners, knocked out 1 trucks and 9 machine guns. C Co took 50 prisoners and knocked out 1 anti-tank gun.
- 6 April 45 C Co with 355th Inf Regt were put back under control of 89th Division, but no substantial changes in position occurred. A Co moved into and through Eisenach with the 353rd Regt. B Co, with 354th Regt made good progress on Division north flank, holding ground until relieved by XX Corps elements.

- 7 April 45 All division elements moved generally south to prepare for advance to southeast. Bn Cp did not move, but was prepared to move on Division order.
- 8 April 45 Hq, Rcn and Bn CP moved to Wahlwinkel (J0159). A and B Companies moved with their respective Regiments to the general area of Friedrichroda. A Co over-ran and destroyed a Mark IValank. C Co continued to screen the front lines around Ohrdruf.
- 9 April 45 All elements of the Division continued mopping up in Zone and prepared for resumption of the abrack to the East.
- 10 April 45 A Co with 353rd Regt remained in Division Reserve. Co C with 355th Regt made excellent progress and occupied Arnatadt (J2653). B Co eith 354 Regt on Mivision right met moderate resistance and was Several kilometers back of the 355th Regt line. B Co CP in Ohrdruf (J1152). B Co had I tank destroyer and I jeep damaged by artillery.
- ll April 45 C Co advanced as far at Tonndorf (J4460) against light opposition. B Co moved up to Marlishauson (J3152). 354th Inf Regt continued to meet the heavter opposition in its sector. Rcn and Bn CP moved to Hokzhausen (j2155). Capt Aldreded and 4 enlisted men received 7 day furloughs to Riviera. Task Force Crater was formed, made up of A Co of the 602nd TD Bn, Co A of the 707th Tank Bn, a Battalion of Infantry and a company of the 314th Engineers. Bn captured a total of 28 prisoners. Task Force assembled on Division order to seize bridges over the Saale River.
- 12 April 45 C Co with 355th Inf Regt occupied Bad Berka (J4961). The 353rd Inf Regt (less one battalion) relieved the 354th Inf Regt in its sector. B Co was relieved from 354th Regt and was attached to the 353. A Co, attached to Task Force Crater contined in Division Reserve.
- 13 April 45 Task Force Crater was committed and by 0800 A Co was up to the Saale River. Hq Co, Rcn and Bn CP moved to Gutendorf (J5352) No serious opposition encountered. McPeek didd of wounds received in action same day. Bn completed first month with 89th Inf Division and sustained only 10 battle casualties, including one killed.
- 14 April 45 Task Force Crater was dissolved, and A Co remained in place. B Co advanced to Eichenberg (J6750). Co C moved up to Trobnitz(J8156). At 1700 a field order was received from Division directing the committment of all three regiments. Companies reverted to normal attachments, A Co with 353rd on the right flank, B Co with the 354th in the cinter and C Co with the 355th on the left.

- 15 April 45 Bn CP and Rcn Co moved to Grossbackedra (J7656). A Co stopped at Triptis (J9145). B and C Companies both located their CP's in Munchen-Bersderf(J9555), which was near enough to the regimental boundaries to be utilized by companies.
- 16 April 45 Bn CP, Hq and Rcn Companies moved to Kofeln (KO353), \*\*MICH The companies continued their advance against very light resistance. A Co to Langen (KO840(, B Co to Weida (KO450), C Co to Linda (K1455). Picture show was held for Hq and Rcn Companies.
- 17 April 45 C Co with 355th Inf Regt attacked Zwickau (K3646) which had refused terms of surrender. Lt Kilborn's Rcn platoon with the aid of an escaped British P.W. made a bold dash through the streets of the town. Although all avenues of approach were defended by Germans riflemen and bazooka teams, the platoon's speed enabled them to reach and secure a vital bridge over the Hulde River. While the platoon was dismounted, trying to cut demolition wires and secure the bridge they were subjected to rifle and machine gun fire. One man was wounded and Pfc Earl Stevens was killed. Stevens, only three days earlier, had been awarded the Bronze Star Medal for his heroic action in saving two of his wounded comrades shortly after the Rhine crossing. B Co also secured bridges across the Mulde River farther south in the zone of the 354th Inf Regt. A Co with the 353rd advanced to the Corps restraining line in the south of Division's Sector.
- 18 April 45 ...cn Co was assembled and placed directly under Corps control to perform much missions as Corps mibht assign. nq and bu CP moved to Zwickau (13644). C Co also in Zwickau was at 13446). Co at Eversvrunn (13238). A Co was at Oberheinsdorf (12835). Higher headquarters indicated that that a brief breathing spell could be expected, so all companies began maintenance periods.
- 19 April 45 Rcn Co received a mission of protecting the Corps CP near Zeulenroda (k0036). Other companies continued maintenance. More than two dozen Bronze Star Medals were awarded to officers and men of the battalion. In almost every instance the ribbons and citations had veen previously presented, but the actual medals had not been available until recently. Picture show was held in Bn CP building for Hq and C Companies.
- 20 April 45 Mainenance continued. Picture show was repeated in the afternoon for members of A and B Companies. Lt Colonel Conlin attended Unit Commanders meeting at Div Hqs. (Report of meeting included in Historical Report).

- 21 April 45 Companies continued maintenance. C Go had two platoons on the line and one in reserve. B Co also had two on thing lines and one in reserve. A picture show was held in the C Company area in the afternoon and again at night at Bn CP. A report came in during the afternoon that Russian prisoners in Zwickau had been fired on by SS men in civilian clothes. Three destroyers which were at Bn Motes Shop, and several armered cars were sent out to find the trouble. It proved to be a case of the armed German civilian guards firing on the Russians. Nothing serious developed. B Co moved to Vielau (K3942).
- 22 April 45 Maintenance was continued. Picture shows were held for members of all companies. B Co reported 1 AT gun knocked out, 3 trucks destroyed, 22 enemy ki lled, and 70 PW's taken during the week.
- 23 April 45 Maintenance continued. Good progress was noted in appearance of men and equipment. Virtually all the men had been able to take showers and most men had been able to get their clothes laundered. Eleven men returned to duty from Hospitals and enlisted strength once again exceeded the 600 mark. VIII Corps passe & to control of First Army, but no immediate affect was felt in battalion affairs. Capt. Tharp and one enlisted man left on temporary duty with the Military Government. Lt. Ranges and Lt Parnell and eleven men left on pass to Paris.
- 24 April 45 Rcn Co continued its mission of guarding the Corps CP and was also able to perform maintenance of vehicles. Other companies also continued maintenance. Capt. Aldredge and 4 EM returned from Piviera. Capt Hart assumed duties of Bn S-2 and Ot Barthold assumed command of B Co. Bn rescived official instructions on recognition of Soviet ground forces; but there were no reports of any contact.
- 25 April 45 Rest and maintenance continued. A picture whos was held in the afternoon. One platoon of B Co was part of a small task force which made an armored patrol to the east to locate and break up a suspected enemy troop concentration. Small groups of enemy were found, but no important concentration was discovered. Our troops suffeped no casualties, estimated 5 enemy killed, and knocked out one observation post.
- 26 April 45 Rest and maintenance continued. Picture show was held in thr evening at Bn CP.
- 27 April 45 Rest and maintenance contined. Battalion received quota of 4 Coca-cola stree/prof per individual; except for a few men it was the first taste of Coca-Colas since our arrival on the continent. Although only a small item, it added considerably the/ to the morale of the men. A picture show was held at 1000 in the morning for B and C Companies and at 1400 for Company A. Another showing at 1900 was held for Hq Co. Troops assignment list was received, assigning 602nd Tank Destroyer Battalion to First Army as of 22 April 1945.

- 28 April 45 Rest and maintenance continued. Lt Mills assumed duties of B Co executive. Co C moved to Lichtenstein (K4541); the platoons, however, made no appreciable change in positions. Shows were held at Bn CP in the afternoon and evening.
- 29 April 45 Rest and maintenance continued. Shows were held at Bn CP in the afternoon and eveling. 22 PW's surrendered to a messenger who was on a routine trip/
- 30 April 45 Rest and maintenance continued. Troops were paid, the stable situation permitting virtually all men to be paid promptly.
- l May 45 Rest and maintenance continued. Lt Ranges and Parnell and ll EM returned from Paris. Lt Menard returned from ######### trip to VITRY to check on guards there. Shows were held in the afternoon and exening.
- 2 May 45 Rest and maintenance continued. Shows were held in the afternoon and evening.
- 3 May 45 Rest and maintenance continued. One platoon of Company B was upt in a small task force with mission of breaking up enemy concentration in front of the 354 Regt. Knocked out or neutralized one observation posts Estimated 3 enemy killed. Shows were held in the afternoon and evening.
- 4 May 45 Rest and maintenance continued. Lt Sabella and 15 men left on pass to Brussels. Another Company B platoon was sent out in a small task force with substantially the same mission as on the previous day. Knocked out one machine gun, one OP, killed or wounded approximately 20 enemy. Shows were held in the afternoon and evening.
- 5 May 45 News of the large scale German surrenders was received with pleasure, but there was no tendencu toward celebrations of any sort. It was apparent that the men would attach little significance to any such news unless they were convinced that the Germans in front of them had actually quit. This was regarded as a desirable reaction. Rest and maintenance continued and shows were held in the afternoon and evening.
- 6 May 45 Rest and maintenance continued. Field order received from Division called for preparation of plans for resumption of attack to the as cast if the enemy in front of us did not surrender. Shows were held in the afternoon evening.
- 7 May 45 Word was received of the unconditional surrender of all German forces. There was jubilation, but no celebration. Most evident was the speculation as to future disposition of the battalion. The arrival of the first mail in over a week caused as much excitement as the surrender news.

602nd Tank Destroyer Bn--I think these are the total number of units we were attache to during our days in the ETO. Information came from a search of the old Unit Journal as prepare by Jim Culp and an old list I made up during the war account I needed to know higher Hgs.

This list is important as we must somehow check unit journals, after action reports, etc of each for the periods we were with them. They received credit for actions of attached units ut usually mentioned those units in the reports as mentioned above. I will send copies of the copies of the copies and Jim Culp for verification along with the other material I have already checked.

- 16 Oct 44-- A Co--738th FA B Co--273rd FA >I havnt the slightest idea who these people were
- 23 Oct 44-- Bn Recieved message of commendation from X11 Corp and 9th TD Group

26 Oct 44--C Co returns to Bn control

27 Oct 44--attached 26th Inf Div

NOTE-- A very confused period. We will have to study each of these unit's records for each day of the month. My records only mention the 4th with various Combat Commands-and the 2nd Cav. (This was the period of Arracourt which my notes say was the biggest tank battle of the war so far (Sept 18 thru Sept 28th) I mention that Oct was spent straightening the line-holding-etc and that we were at times with Corps Arty for indirect firing. I also mentioned the 35th Inf Div. (I do remember seeing an Inf attack up a poppy cushioned hill at terriffic cost--and seem to remember that one of our companies supported them with direct fire)

I tried to contact Col Hayden Sears as he was an old friend of our Colonel-his wife gave me the General's address but Col Sears is in the hospital-
